The Georgia Living Store is a consignment shop for our exhibitors (ages 18 and above) in the Georgia Living Program. In order to sell anything in the Store, you must be a 2009 participant in one or more of the competitions available at the Fair.

**What kinds of items are we looking for?** We hope to stock the Store with a wide variety of *quality* items that have been hand-made (a must!) by our talented exhibitors...woodcarving, pottery, photos, decorative arts, hobby crafts, needle arts, quilts and quilted items, crochet...if you make it, we want to sell it for you. There are some exceptions, however. We are not able to sell food items or canned goods unless *you are licensed* to sell those products. Space is limited; therefore, we will not be able to accept framed fine art or other items that are unusually large. Additionally, we will not knowingly accept items that are soiled, aged or made from kits. We reserve the right to reject items that may be objectionable.

**How many items will you be allowed to bring to the Store?** Our space is limited, but we will be selling for 10 days, so we will need a good number of items. Plan to bring up to 30 items; if we sell out and need more from you, we will call you to restock! There are no minimum limits. However, you should plan to consign enough inventory to cover the expense of including your items in the store.

**How will we keep up with inventory and sales for each person?** You will be assigned an exhibitor control number when you call to sign up for the program. You must tag each of your items with your assigned control number, your own inventory control number, description and price. These numbers must match your inventory list which will be turned in to the Store with your items. Please use the form on the back of this sheet (the form may be duplicated). We request that you use tie-on tags (tags with strings). Tags will be removed at point of sale for inventory control.

**How much will it cost you to participate?** 20% of sales to cover costs of operating the Store, plus some of your time as a volunteer worker in the store, if possible.

**When will you receive your money?** Accounts will be settled after the Fair is over. Checks will be processed by November 30, 2009.

**To sign up: call, email or fax.** We will give you a control number at that time. However, we ask that you not request a control number unless you are certain of participating. As soon as you have your inventory list complete, **send a copy to us** so that we will have an idea about what's coming in September.
